If you wish to waive this hearing and have your child receive the above placement, you must sign a Waiver Form which you may do so at the school. **Please notify the principal of your intent within two (2) days of signing the Notification of Recommendation of Suspension.....form.**

Student, under this suspension, shall neither attend the base school; participate in any school extracurricular activities; or practices, nor be on any school campuses other than Darling Achievement Center, or at any school - sponsored function, for the duration of the suspension.
